**LOCAL LAW NO. 2 OF 2026
COUNTY OF ROCKLAND
STATE OF NEW YORK**

(Introduced by Hon. Jay Hood, Jr. and Hon. Lon M. Hofstein)

WOLFE/HOFSTEIN, MALOWITZ: M.V.

A local law providing for the salaries of certain county officers of the County of Rockland.

Be it enacted by the legislature of the County of Rockland as follows:

Section 1.

Notwithstanding any previous local laws or resolutions, the annual salaries of the hereinafter designated county officers are hereby fixed at the following amounts to be paid effective January 1, 2026:

County Clerk	\$208,200
County Executive	\$234,000
Sheriff	\$234,000
District Attorney	\$234,000
Chairperson of the Legislature	\$93,795
Legislator	\$71,600

Section 2.

Effective January 1, 2026, the above referenced officers shall receive the respective salaries set forth herein. Such salaries shall be retroactive to January 1, 2026, if this law becomes effective after that date.

Section 3.

All local laws and resolutions of the Legislature of Rockland County or the former Board of Supervisors of Rockland County, to the extent that the same are inconsistent with this law, are hereby superseded by this law.

Section 4.

Nothing contained herein shall prohibit the Legislature from fixing a different salary for prospective appointees for the positions set forth in this local law at the time of such appointment or prohibit the setting of a salary of any official described in this local law by resolution, at any time that such an adjustment by resolution would be permissible under New York State Law.

Section 5.

This local law is adopted subject to a permissive referendum, and the clerk is directed to publish notice of same as required by law.

Section 6.

This local law shall take effect immediately upon its filing with the New York State Secretary of State.




I FURTHER CERTIFY that at the time said Local Law was adopted said Legislature was comprised of seventeen members.
