

LOCAL LAW NO. ____ OF 2026
COUNTY OF ROCKLAND
STATE OF NEW YORK

WOLFE/CLEARY: UNAN.

A local law providing for the salaries of certain County Officers of the County of Rockland.

Be it enacted by the Legislature of the County of Rockland as follows:

Section 1.

Notwithstanding any previous local laws or resolutions, the annual salaries of the hereinafter designated County Officers are hereby fixed at the following amounts, retroactive to January 1, 2026:

County Auditor AUD1320-1100	\$207,597 (\$199,894 salary plus \$7,703 merit bonus)
Commissioner of Elections (2 positions) BOE1450-1100	\$150,717
Commissioner of Human Rights HRC8040-1100	\$101,426
Commissioner of Personnel PER1430-1100	\$262,947
Commissioner of Social Services DSS6010-1100	\$272,090
Medical Examiner DOH1185-1100	\$278,435
Public Defender PDF1170-1100	\$243,722
Real Property Tax Services Officer FIN1325-1100	\$151,751

Section 2.

Effective January 1, 2027, as per the requirements of Resolution No. 505 of 2023, each of the annual base salaries of the officers referenced in Section 1 shall increase an additional 3% over the base salaries in effect on December 31, 2026.

Section 3.

Effective January 1, 2028, as per the requirements of Resolution No. 505 of 2023, each of the annual base salaries of the officers referenced in Section 1 shall increase an additional 3% over the base salaries in effect on December 31, 2027.

Section 4.

All local laws and resolutions of the Legislature of Rockland County or the former Board of Supervisors of Rockland County, to the extent that the same are inconsistent with this local law, are hereby superseded by this law.

Section 5.

Nothing contained herein shall prohibit the Legislature from fixing a different salary for prospective appointees for the positions set forth in this local law at the time of such appointment or such other time in any manner permitted by law.

Section 6.

This local law is adopted subject to permissive referendum and the Clerk is directed to publish notice of same as required by law.

Section 7.

This local law shall take effect immediately upon its approval by referendum or otherwise provided by law.




